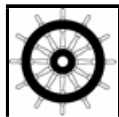

Primary deck covering, not generating excessive quantities of smoke nor toxic products in fire.

The product may be applied over any steel or non-combustible material.

Approved colour (tested colour): brown (component A), red (component B)

Maximum organic content: 55 %

Mixing ratio A : B = 1 : 6

Not to be used as an integrated part of horizontal class A division unless tested as such.

The product may also be used as floor covering in accordance with IMO 2010 FTP Code Part 5 appendix 4 paragraph 4.9.2.
